#### **CALL TO ORDER**

#### MINUTES - Jackie

The minutes of the January 25, 2021 Board meeting were approved by a majority of the members via email and were posted on the Sol y Lomas website by Dave.

# TREASURY REPORT - Kathy

The HOA bank accounts have a balance of \$5,001 in savings and \$9,076 in checking. An amount of \$3,865 has been received in dues for 2021 from 113 lot owners. Forty dues were received via PayPal and 73 via checks. Six lot owners responded to the letter sent out to those who had not paid dues for the past two years, totaling \$330 received. In one case five years of dues were paid. Fifteen lot owners opted for electronic notifications rather than paper. It was noted that those residents who had paid dues via PayPal had no way to indicate their desire for electronic notifications. An email will be sent to those forty owners asking if that is their preference. Sending an invoice to those who have not yet paid their 2021 dues will be discussed at the March Board meeting. A thank you was made to Holly for setting up the PayPal account.

### **NEW BUSINESS**

#### **Memorial for Kellie Ontiveros**

After discussion it was decided to put this matter on the agenda for the next Annual Meeting in January, 2022, for discussion and a vote. In the meantime a donation will be made to The Food Depot in 2021, as has been done since 2016. Jackie will draft a response to the homeowners.
