CALL TO ORDER

TREASURY REPORT – Kathy

Kathy made a motion to send a second notice to those Lot Owners who usually pay their dues but have not done so for 2021. Jeanette seconded the motion which carried. As stated at the meeting, all delinquent dues will be collected at the time of the sale of their properties.)
