NEW BUSINESS

FOOD DEPOT

Susan reported she had received a letter from the Food Depot about their neighborhood fall food drive. For the past several years, the HOA has made a cash donation to the Food Drive rather than make a collection of food. Last year a HOA homeowner questioned the Board's authority to make such a donation without getting a vote from the HOA membership. It was noted that in the HOA's proposed budget for 2021 there was a line item for The Food Depot in an amount of \$400. The proposed budget was voted on at the Annual HOA Meeting held in January, 2021. Susan will mail the \$400 check to The Food Depot. Following the Food Drive, an invitation will likely be received from the Food Depot for a HOA representative to attend a thank you reception. WELCOME LETTER

It was noted that the Welcome Letter given to new HOA residents was not on the Sol y Lomas website nor in Google Docs. Jackie had emailed a copy of the current letter to all the Board members prior to the meeting. Susan reported she would get the letter onto the website and into Google Docs.

DISTURBING NEIGHBORHOOD ACTIVITY

There was a recent incident on Tecolote in which the window of a vehicle was broken and soon afterwards an unruly motorist on West Zia became aggressive toward a walker. Everyone was encouraged to be very aware of their surroundings and to report any such activity to the police immediately.
