Treasury Report - Holly

Holly reported balances in the Sol y Lomas HOA bank accounts are as follows: Checking \$7,481.05 and Savings \$1,013.56. Additionally, the HOA has a \$10,000 CD which will mature in February 2026. Expenditures during the past month included a donation of \$400 to the Food Depot, \$200 to beloved mailman Tom Grannis for help with his wife's medical expenses, and a \$20 PRC filing fee.

Holly reported receiving one more \$35 dues check for the property at 131 Ridgecrest Drive. Since back dues are still owed she deducted \$35 from the owed balance.

Susan offered to check on a new email address for Pat Ives since a recent email to her email address on file was returned.

Architectural Review Committee (ARC – Wally, Chair)

Wally reported the ARC received no new submissions in October and there are no open cases.
